- Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.
- The Congress shall have the power to enforce, by appropriate legislation, the provisions of this Article.
- This Amendment shall take effect two years after the date of ratification.

A handful of rights for women? ... or full and permanent equality?

But they couldn't take away our rights now... or could they?

Despite the many rights that women have won over the past decade, equal opportunity and equal treatment under the law are incomplete and impermanent. Limited equality has been granted by dozens of laws, regulations and court interpretations that let too many abuses slip through the cracks.

Worse, women's rights could be revoked if changes occur in the political balance of Congress, the philosophy of the Administration, or the make-up of the Supreme Court.

The Equal Rights Amendment will make women's gains permanent. Once equality of men and women is written into our fundamental law, only an overwhelming consensus of the American people can remove it.

ithout the ERA in the Constitution: The shift of a few legislative votes could wipe out equal employment opportunity, equal access to credit, and equal education.

One or two appointments to the Supreme Court could wipe out rights that you consider fundamental – rights which actually depend on court amplifications of ambiguous laws and legal principles.

ith the ERA in the Constitution: Equal rights and opportunity for women will be fundamental law, as much a part of our system as the right to vote, freedom of the press, and the separation of church and state.



any women's rights laws were enacted by small margins.

The law that gives a woman the right to sue an employer who discriminates against her would not be on the books if three Senators had changed their votes.

The breakthrough federal law against sex discrimination would have been filibustered to death if only two more Senators had voted against it.

Victories won in the Supreme Court are equally vulnerable. Appointments within the past ten years have cut many of our victories to one-vote margins, and we have suffered some important defeats.

Changes in the courts and legislatures have already begun to erode our victories. ERA will protect our rights.

ERA means permanent equality.

he Equal Rights Amendment, once written into the Constitution, will put women's right to equality beyond the reach of politics and changing policy. It will extend the American ideal that all people are equal.

Furthermore, the Equal Rights Amendment will give a clear constitutional basis for overturning dozens of state laws still on the books that fail to give equal treatment to men and women.

It's time to gather together all our piecemeal victories won in the legislatures and the courts, and to engrave them into the Constitution with one simple, comprehensive statement that gender will not be a cause for discrimination.

But the Equal Rights Amendment is not yet law. Why? Because a few state legislators, ignoring the wishes of their constituents, have bottled it up in committees, tied it up in parliamentary technicalities, and used backroom political pressure to swing votes against it.
