ILLINOIS DEFEATS ERA FOR THE SEVENTH STRAIGHT YEAR

The Illinois House defeated ERA again on Thursday evening, June 22. This was the most amazing political victory of the decade. Lined up on one side were the Carter Administration, Illinois Governor James Thompson, Chicago Mayor Bilandic, and the Chicago newspapers. On the other side were the people. For once, the people won out over the federal and state officials and the media.

This is the seventh year that the Illinois Legislature has debated and voted on ERA, and the 13th time a vote has been taken in one House or the other. It is a perversion of the democratic process to make a legislature vote again and again on the same issue. The lain purpose of the pro-ERAers is to wear people out by voting again and again, in the hope that legislators will finally give up and pass it.

It was a colossal piece of pro-ERA rules chicanery that ERA was even brought up for a vote on June 22. ERA had already been twice defeated by this legislature. June 7 was the second time ERA was defeated by this very legislature, and the ERA bill was dead. So what did the libs do? They simply introduced another bill with identical wording, rammed through a vote to bypass committee, and demanded and got a third vote in this legislature. This tactic is a violation of all rules of orderly legislative procedure.

The June 7 rejection of ERA was a rebuff to President Carter, who had come personally to the Illinois Legislature the week before and asked legislators to vote for ERA even though they suffered a backlash from their constituents! This arrogant statement was tantamount to admitting that the people are against ERA. After the Illinois House defeated ERA on June 7, Vice President Mondale came to Chicago to voice the Administration's displeasure and to demand that ERA be passed. The Carter Administration threatened to make Chicago Mayor Bilandic's life miserable by withholding federal funds unless the Mayor

forced Chicago-area legislators to vote yes on ERA.

The voting on June 22 went on for several hours as each Representative explained his vote. It was a traumatic experience for those present. The Speaker held the vote open while the proponents went up and down the aisles pleading for additional votes. Paid ERA lobbyists worked hard. Illinois Governor Thompson made personal, pleading phone calls direct to the desks of legislators asking them to vote for ERA, and the Governor's men were lobbying on the House floor.

The ERAers are in a state of shock at their stunning defeat. They don't understand why they lost. They simply won't face up to the fact that Illinois citizens do NOT want ERA. The National Organization for Women has been threatening on TV and radio to defeat all legislators who voted NO on ERA. Pro-ERA money is pouring into Illinois by the hundreds of thousands of dollars. The League of Women Voters alone has announced that it has allocated \$140,000 to Illinois. Carol Burnett has called legislators and offered to come in for fund-raisers. Rosalynn Carter said she is keeping a list of state legislators who voted against ERA so they can be replaced (a White House enemies list).

The ERAers promise to bring up ERA in both the House and the Senate in the November session after the election. Whether ERA passes or fails in Illinois will depend on who is elected in November. ERA proponents have made Illinois their key target and, unfortunately, money is a vital factor in political races. That's what the ERAers have lots of -- plus dozens of federal and state payrollers who work for ERA at the taxpayers' expense.

We salute the courageous Illinois legislators who had the courage to stand up to the political and financial pressures thrown at them by the Carter-Mondale Administration and Gov. Thompson, the hammering of the press, and the harassment by the NOW radicals.
