1976 VICTORIES OVER ERA!

VIRGINIA: On Feb. 4, the Virginia Senate Committee defeated ERA. This killed ERA for the rest of the year! An attempt was then made to bring up ERA in the House, but it failed there, too.

KENTUCKY: On Feb. 19, the Kentucky House rescinded ERA by a vote of 57 to 40. The rescission motion is now in a Senate Committee.

It is really comical to watch the hysteria of the EMA proponents over this rescission by the Kentucky House. If they believed their own propaganda about rescission being invalid, they wouldn't care when a Legislature passes a rescinding motion! But they are so upset that they are incoherent! They have imported into Kentucky the top pro-ERA VIPs in order to try to stop the rescission motion from passing the Senate.

RESCISSION OF ERA

DO BABIES NEED A MOTHER'S CARE?

State nurseries for all children, regardless of family income, is a major objective of the anti-family women's lib movement. This is a natural corrollary of their rationale that it is so unfair for society to expect mothers to care for their babies, and mothers must be relieved of this unequal burden in order to achieve their full equality(by working in more fulfilling paid employment, such as coal mines, construction work, etc.).

To most people, it is a self-evident truth that babies need a mother's care for proper

growth and development.

But for those who need this truth to be scientifically proved, there is an excellent 30-minute 16 mm movie which does a most convincing and effective job. It is called "ROCKABYE BABY." It is a TIME-LIFE film, and is available from most public libraries at free or low-cost rental for showings to your groups. Basically, the film shows scientific experiments which prove that babies and monkeys are retarded when they are deprived of the regular and loving care of a mother.

I highly recommend this film for showing in schools, to young people, and to others who need to be persuaded that mothers are better for babies than state nurseries.

SINGLE-SEX COLLEGES

My Feb. P.S. Report described in detail why ERA will make it impossible to maintain or attend a single-sex college -- because, by definition, such a college discriminates on the basis of sex. It is important to note that the pro-ERAers are NOT denying this:

(1) I debated Betty Friedan on Boston TV and used this argument. She is a Smith College graduate (all-women's college). She did

not deny this.

(2) I debated Karen de Crow, the head of NOW, at Yale University. She did not deny it.

(3) I used this argument at a press conference in Washington, D.C. which was reported in the NEW YORK TIMES. The reporter apparently phoned the IWY Commission to get their rebuttal. While the IWY spokesperson tried to deny another point, there was no refutation of the point about single-sex colleges.

There are at least 50 all-women's colleges in the U.S. I don't care whether they go coed or not; I personally prefer coed colleges. But it certainly shows the irrational and totalitarian compulsion of ERA that it will use the great power of the Federal Government to wipe out single-sex colleges.

"NOW" MOVES IN ON ILLINOIS, FLORIDA, INDIANA, MISSOURI AND NEVADA

On Feb. 15, the National Organization for Women (NOW) ran a \$10,000 ad in the NEW YORK TIMES soliciting money and workers to lobby for ratification of ERA. The ad stated:

"We've established the NOW ERA fund to channel contributions to Illinois and to Florida, Indiana, Missouri, and Nevada -- where ERA campaigns are underway and ERA votes are pending. ... Illinois is a NOW priority. ... NOW has established a statewide organization to lobby, publicize, and politick for ERA in Illinois. ... Our major undertaking is planned for one month before the state Senate vote: a weekend of door-to-door canvassing for ERA, statewide and in key districts. On this 'National Equal Rights Weekend, 'we will bring thousands of Americans and many prominent speakers to Springfield to focus attention on the state legislature. Similar actions are planned in other NOW priority states throughout the year. NOW is doing its part for ERA."

There are two things you have to give the NOW women libbers credit for: (1) they work hard, and (2) they put their money where their mouth is.

The question is, do you? Do you (1) work as hard as they do? (2) with as much perseverance and determination and single-purpose dedication? (3) putting aside petty personal differences and always keeping your eye on the larger objective? (4) do you put your money where your mouth is? (5) backing the candidates who stuck by us and voted NO when we asked them to?
