1. INTERNAL SECURITY:

Mr. "Rosie" Matsui, Chief of Police, thanked the community for their efforts expended in retrieving the body of the drowned boy in the Garland Canal. Upon request from the Council he gave a detailed report of the procedure he had confronted in securing assistances from the various groups. The Executive Secretary was asked to write a letter of thanks to Mr. Sam Launchberry, Sheriff Frank Blackburn, and Mr. Paul Nelson, Superintendent of the Shoshone Irrigation District.

Mr. Matsui also asked the Councilmen to warm the parents of the children that anyone playing with sling shots will be strictly investigated.

2. JANITORIAL SERVICE:

Mr. S. Nagumo suggested that all arrangement of janitorial service for the recreation halls be made by the janitorial service department. The suggestion was approved by the Council and Mr. Nagumo was advised to inform Mr. Hosaka of the janitorial service.

3. SANITATION:

Mr. T. Takahashi of Sanitation Committee reported that there is no possibility of sending TB patients to the hospital at Basin. The TB test was conducted at the high school to make a survey of the possible TB cases. There are 14 patients at the hospital, and although hospital authority is considering another building for housing these patients, the building materials are difficult to secure.

He announced that a poster, "Eat Slowly for Health Sake", has been posted in the mess halls. The ambulance service has been improved considerably and at present there are less complaints from the residents. He was asked to advise the Councilmen to inform the residents not to bring food to the patients at the hospital.

Mr. Matsushige of Social Welfare Committee advised the Council that obtaining of doctors' signature on sick leave absence is handled by Miss Thomas, Medical Social Worker.

Erdman, Mr. Matsushige, Block 6 councilman, said that repeated requests for the installation of those wash tubs which were destroyed by fire had been made through the Block Manager. Secretary was asked to send a memo to Mr. Anderson on this matter.

6. REST HOME:

Mr. Matsushige of Social Welfare Committee reported that furnishing of cooking utensils to the occupants of the Rest Home is under consideration of Miss Payne, Counselor. At present they are eating at 23-27 mess hall.

7. RECREATIONAL EQUIPMENTS:

To the request made by Mr. Takahashi, Block 30 Councilman, for recreational equipments for the children who cause much disturbance at laundry rooms, Mr. Katagi of the Recreation Committee said that CA is making every effort to secure them. Due to WPB regulation the materials for constructing equipments are very hard to obtain. Mr. Nakaki announced that Managers have made requisition to Mr. Todd to furnish swings and seesaws for each block.

Hatchimonji called the attention of the Legal Committee on the draft of Jair Labor Practice Committee that following provisions be included in the draft: a. According to the WRA instruction 50.5, Council shall be connected with the Fair Labor Practice Committee in some capacity; b. the instruction 50.5 shall be component part of the Fair Labor Practice Committee draft; c. In case of conf; lict between the draft and the WRA instruction 50.5, the latter shall prevail; d. The provision be provided in the draft for the revisions or amendments. He reported on the discussion of maid problem with Mr. Anderson and Mr. Sashihara. He advised that the Project Director and C. E. are understood to have considered \$35 an equitable monthly wage to be paid by the employer, and that the regular "RA wage plus clothing allowance be paid to the workers. 1. LOST BAGGAGE

As stated in the communication received from Mr. Burnett on the lost baggage, Mr. Matsushige further added that Mr. Burnett is negotiating with San Francisco and Washington on this matter. Since the government assumes no responsibility for any form of loss through handling of evacuee property, the individual has no recourse for collection of any claim unless he cares to take it up through the Small Claims Division in Washington, D.C. However, the government only pays 10¢ a pound regardless of what the value of the lost baggage. Also in regard to the baggage Jost on shipment from the West Coast, the Railroad Company is responsible, but it also pay only 10¢ a pound regardless of the value of shipment.

2. COAL

Chairman reported that most of the mess halls coal supply is well screened our and the laundry rooms supply is quite depleted. He has requested Mr. Main to supply the residents with another car a day since some of the showers were without het water. And to those blocks whose coal supply is not screened, he requested that block volunteers screen the piles so that the crew in charge will be able to haul the unuseable residue away.

3. COMMUNITY ENTERPRISES

The discussion relative to conducting a hearing on the Community Enterprises Study and Negotiatinn Committee was continued from the last meeting. Various opinions were expressed, but since it involves the welfare of the community, the council voted in favor of having the Resolution Committee composed of Mr. Kimoto, Mr. Matsushige and Mr. Nakaki (replacing Mr. Tokimasa who is the member of the executive committee of the study and negotiation committee of C. E.) make a further study of the matter and submit recommendations to the Council.

4. FOOD COM ITTEE

Mr. Hayashida of the Food Committee reported to the Council that the supply of shown has been temporarily curtailed due to the army ordering from another party, and practically all mess halls are depleted of their supply. He presented a motion that request be submitted to the Supply Department of the Project to purchase shown from Community Enterprises. The motion was unanimously approved and the Council Food Committee was requested to negotiate with Mr. Main.

5. INVENTORY

Mr. Larson, Cost Accountant, attended the meeting and reported that order has been received to make inventories of the government properties (cots, matteresses, blankets, etc.) that are being used by the evacuees. He asked for the advice from the Council as to how this matter be handled. The Council suggested that it be made with assistance of block managers and clerk from the administration. He announced that it will be published in the Sentinel bulletin that the activity will be conducted on Friday and Saturday.

6. DOCTOR

A motion to request an arrangement whereby doctors could be called into the apartment in emergency case was made by Mr. Kimoto. Mr. Hatchimonji described a case in this connection which occured recently in his block. The motion was approved as a topic for discussion at next round table meeting.

7. APPRECIATION FUND

Mr. Takashashi asked the Council for suggestions as to how the distribution and publication of the appreciation fund should be made, since block 22 has not contributed. The Council requested information from Mr. Tokimasa why his block was not cooperating with the others in this matter. Since there was no time left, the matter was left on the table for further discussion at next meeting.

Meeting was adjourned at 11:45 a.m.

Dear

From many sources I have learned that military authorities no longer think that military necessity requires that people of Japanese descent be kept out of the Lest Coast.

Why then are we, who are sending our sons, our brothers and our friends to battlefields to fight for America, not permitted to return to our former homes? It is because certain groups in the Vest Coast, due to selfish economic interests for the most part, are organized and active. They have flooded Vashington with thousands of letters protesting against our return.

Now, we have thousands of friends on the Coast who accept us for what we are. Some of these friends have already raised their voices in our behalf. "Friends of american Way" of Pasadena, California and others have been instrumental in helping us.

Would you kindly write letters for me and others like me, to the men whose names and addresses are given below? I have been reliably told that they have more to say than anyone else on the question of lifting the ban on the Japanese. What will be most helpful are statements from you that we will be welcome and that we have or could find places to live and means of earning a livelihood there.

I may further add that I am aware that there are persons on the Coast who are friendly toward us but who think we were concentrated too much in the three Facific states. Some such persons may oppose lifting the ban for fear that all of us will rush back. However, there need be no worry on this score as many of our people have already gone to Mid-western and Eastern states and are well settled there and are not thinking of returning to the West Coast. But those who have no desire to return agree with these who wish to do so on one point: that is, THE EXCLUSION ORDER IS UNFAIR AND UNDEMOCRATIC AND IT SHOULD BE RESCINDED.

I realize that writing the letters I have requested will take some of your valuable time. Be assured, however, that you kindness will be deeply appreciated.

Minutes of July 18 and 19 were approved as read.

Communication Reviewed:

- a. From M.O. Anderson, Assistant Project Director, attachments of a letter on the relocation grant to inductees; on care of playground equipment; a supplement to Animal regulation.
- b. From Butte Community Council, minutes of the Council meeting of July 5 and a copy of Juvenile Code.
- c. From Tom Ozawa, resignation from the secretary to the Community Council.

1. SOCIAL WELFARE

Mr. Matsushige of Social Welfare Committee reported on his interview with Mr. Orville Crays, Technical Consultant, Welfare Section, Wishington, D. C. on the matter of grating clothing allowances to all center residents. It is Mr. Crayst opinion that there is a possibility of alloting clothing allowances to all center residents. On the question of Block system of granting leaves to local towns, his consultation with Miss Payne revealed that the system is impractical due to inconveniences for the applicants who wish to go with their friends. Now, Mr. Matsushige added that the leave is granted once a week to a person who wish to go to Powell, while leave to Cody, every day.

2. LABOR

Mr. Hatchimonji of the Labor Committee presented the Fair Labor Practice Committee draft with corrections and necessary provisions inserted. He stated that fifty copies will be made for distribution to the Councilmen for final review before presenting it to the Administration for approval.

3. ARRANGEMENT OF DOCTOR'S SERVICE

The Chairman reported that he and Mr. Anderson had negotiated with Dr. Irwin on the matter of arrangement to have doctors call at individual home in case of emergency. Dr. Irwin advised that this system will tend toward the former policy of over-burdening the limited member of doctors, and if the case of a sick person to call doctor is left to the discretion of the Block Manager or the Councilman, it will be the cause of disharmony with in their respective blocks. Therefore, he did not consider our suggested plan feasible.

4. COMMUNITY ENTERPRISES

After thorough discussion on the request made by the Executive Committee of the Study and Negotiation Committee of the Community Enterprises to have a hearing on the charges made publicly to the said committee by the other members of the committee the proposal to have a hearing was voted down by the majority vote of the Council.

5. APPRECIATION FUND

Due to the fact that Block 22 is the only block not contributing to the doctors' appreciation fund, Mr. Saito made a motion that Council shall be author - ized to solicit contribution for this purpose. The metion was approved by the majority vote of the Council.

The chairman stated that there is much unfinished business on the table and therefore he called a special meeting for tomorrow, Saturday July 22, 1944, at

Special meeting of the Community Council was called to order by Chairman Nakashima.

ROLL CALL:

Absentee: Mr. Katagi (28); Mr. Saijo (17); Block 24.

- 1. Mr. Miyasaki, Block 15 Councilman, presented a motion from his block that a now committee composed of one representative from each block shall be organized to handle all matters concering the doctors' appreciation fund. Discussion was held, but since this question in block 22 is not settled, the motion was tabled for further consideration at the next meeting.
- 2. BLOCK COORDINATOR'S POSITION

Discussion was held on the proposal to request continuance of the Coordinators position on payroll. There seemed no adequate job that could be had with practically full time consumed on the Councilmon's duties. The motion was made by Mr. Saito and amended by Mr. Nagumo that an appeal be made to the Administration that Block Coordinator's position be maintained. The motion was unanimously passed and Executive Committee of the Council was asked to negotiate with the Administration.

The meeting was adjourned at 11:30 a.m.

Meeting was called to order by Chairman Nakashima.

Minutes of July 25 was corrected as follows: Under the Food Committee reports, to read "that ration points allowed are not being used to their full extent" instead of "that points are being returned" and under the Doctors' Appreciation Fund, the word "resumed" has been changed to "started".

A. Letters from the T.T. Sashihara, Chairman of the Community Enterprises Board of Trustees, on rental payment of optometry equipment and on the petition for the Scholarship Fund.

CO MITTEE REPORTS:

1. Relocation & Commettee

Mr. Nagumo reported that a schedule of five meetings for Mr. Rwoichi
Fujii concerning relocation was made and he asked for the cooperation from
the neighboring block Councilmen.

2. Recreation Committee

Mr. R. Katagi reported that the Community Activities called a meeting about a community wide Memorial Services for men lost in action. The delegates from the respective organizations discussed and decided unanimously that the Community Council should be the sponsoring body for the ceremony. The program for the ceremony was to be planned later.

Mr. Katagi made a motion, seconded by Mr. Saijo, that the Community Council be the sponsoring body for the memorial services of the Center. Motion was passed unanimously.

Mr. S. Nakashima was elected Chairman of the Committee and he appointed a standing committee of three members consisting of Messers. S. Nagumo, R. Katagi, and H. Matsushige. In blocks wherecasualities were reported, the respective Councilmen will automatically serve on the Committee.

3. Executive and Sanitation Committees

Mr. M. Hayashida made a report concerning the Dental Clinic petition and discussion was held. Mr. H. Matsushige made a motion that the Committee submit their recommendation based on their findings with the petition which was referred to the Community Council to Mr. M.O. Anderson, Assistant Project Director for consideration.

4. Rosolution Committee

Mr. H. Matsushige made a report on the findings of the C.E. Study and Negotiation Committee. After conferring with Mr. Byron Ver Ploog, Project Attorney, Mr. M. Hayashida reported that Mr. Ver Ploog will make a written statement to the Community Council Concerning this matter.

OLD BUSINESS

5. Doctors' Appreciation Fund

Mr. Z. Saito reported that at the special meeting held in Block 22, the residents of said block are willing to cooperate. He requested the neighboring Councilmen, Messrs. Nakashima, Oka, Miyazaki, Takahashi, Tokimasa, and Saito, to assist with the collection.

6. Group Pictures

That Chairman reported that Mr. George Nakaki made arrangements with the photographer for the group picture of the Second Community Council to be taken on August 1.

7. Scholarship Fund

Discussion was held on the petition for the Scholarship Fund which was referred to the Council from the C.E. Board of Trustees. The Council decided to put this matter on referendum as suggested by the Board of Trustees. The following resolution was unanimously passed by the Council:

Whereas, the petition tendered by the Y.P.C. requesting the Community Enterprises of Heart Mountain Relocation Center for \$2400.00 out of the unclaimed fund of said Community Enterprises has 1.538 signers; and

Whereas, the recipient of said petition, namely, the Board of Community Enterprises trustees requests the Community Council of the Heart Mountain Relocation Center to determine by means of a general voting of the voters of said relocation center whether to grant said sum to the scholarship fund or not.

Therefore, it is resolved that the said Community Council shall put this matter to a referendum on August 7 at the date when election for new Councilmen is to be held.

1. Executive Committee

Mr. Nakashima reported that according to Vr. Glen Hartman, Chief of Agriculture Section, Mr. Olsen will be placed in charge of the Poultry and Hog Projects with one general foreman and three sub-foremen. The subforemen to the general foreman to Mr. Olsen who will make all recommendations for employment and termination.

2. Food Committee

Mr. M. Hayashida reported that since the budget allows approximately \$. 44 per person daily the high edst of meat and canned fruits and vegetables sometimes prohibited the full use of food ration points to be consumed.

April, May and June were as follows:

Meat ration points allowed annually are 6,989,480 of which 6,275,369 were used. Canned vegetable ration points for last year allowed 5, 365, 231 of which only 2,843,146 were consumed as more fresh vegetables were available.

3. Clothing Allowance

The Chairman asked Mr. H. Matsushige of the Welfore Committee to request Miss Virgil Payne, Counselor of the Social Welfare Section, to communicate with Washington, D.C. for the realization of clothing allowance for all center residents as previously agreed upon by the Social Welfare Counselor Conference held in Washington, D.C.

4. Community Enterprises Study and Negotiation Committee

Mr. Hayashida, Vice-Chairman of the C. E. S. J. Committee, read a memo from Mr. Ver Ploeg, Project Attorney, addressed to Messrs. Hayashida and Tokimasa suggesting that a meeting be called if possible to dissolve the said Committee formally in order to maintain neace and harmony in the community, although present decision made by the C.I. Board of Trustees to accept the request of 22 members of the committee to recognize dissolution of the committee is correct, Wr. Hayashida requested one week nostponoment of the discussion relative to forming a new C. E. S. N. Committee. The Council agreed with the Project Attorney's advice and met with Mr. Hayashida's request.

5. Coordinating Council Meeting

Mr. G. Nakaki was in receipt of a memo from Mr. W. O. Anderson, Assistant Project Director, suggesting that two additional Council representatives attend the Coordinating Council meetings. It was agreed that Messrs. Tsunokai and Nagumo be selected to accompany Mr. G. Nakaki to the meeting next Tuesday, August 1, 1:30 p.m.

6. Special Sentinel Edition

Mr. M. Tsunokai and Mr. M. Hayashida were appointed to serve on the Committee to inquire into the reasons why the Second Anniversary issue of The Sentinel cannot be issued free of charge.

7. Memorial Services

Mr. S. Nakashima brought up the suggestion that a delegate from the Council attend the private services for soldiers lost in action. The suggestion was unanimously agreed upon to take offect as of date. Mr. S. Nakashima was selected to represent the Council at the Memorial Service for Lt. Kei Tanahashi and Mr. M. Hayashida to be the delegate to the service for Corp. Yoshiharu N. Aoyama.

8. Appointment

Mr. K. Hatchimonji expressed his desire to be included on the . Education, Committee in order that he may assist in the Scholarship . Fund Drive. He was appointed to serve temporarily on the Committee,
