MONDAY, SEPT. 24.

J.M.F. REPORTS, FROM CHEYENNE, W.T.: "THIS DAY WAS PUT IN IN COMPLETING ARRANGEMENTS FOR TAKING MY DEPARTURE OF THIS PLACE FOR RAWLINS. I
SAW THOMELSON THIS MORNING, AND LEARNED THAT IT WAS IMPOSSIBLE FOR HIM
TO LEAVE ON THE MORNING TRAIN; SO IT WAS DEFERRED UNTIL EVENING WHEN I
LEFT WITH HIM FOR RAWLINS, HE BEING THE ONLY MAN THAT COULD BE OBTAINED
TO GO.!!

TUESDAY, SEPT. 25.

J. M. F. REPORTS, FROM RAWLINS, W. T. : " ARRIVED AT THIS POINT AT 2:30 THIS MORNING; WENT TO THE MAXWELL HOUSE, AND WENT TO BED; WAS CALLED AT 8 A. M.; ATE BREAKFAST, THEN SENT FOR SHERIFF MILLER, WHO CAME DIRECTLY TO MY ROOM. AFTER SOME CONVERSATION WITH HIM, I PULLED THE REQUISITIONS OUT OF MY POCKET, INFORMED HIM OF MY MISSION AND GAVE HIM ORDERS WHAT I DESIRED HIM TO DO AS AN OFFICER, AND HE GOVERENED HIMSELF ACCORDINGLY, SO AS TO LEAVE FOR THE VICINITY OF YOUNG'S PLACE, TOMORROW MORNING. I LEARN-ED THAT JOHN DURBIN WAS IN TOWN, AND SENT FOR HIM TO COME TO MY ROOM, AND AFTER A SHORT CONVERSATION, LOOKING HIM SQUARELY IN THE FACE I TOLD HIM THAT I WAS GOING TO PLACE MY LIFE IN HIS HANDS, IN CONNECTION WITH SHERIFF THOMELSON; INFORMED HIM THAT I HAD A VERY IMPORTANT MISSION TO SEND HIM ON, WHICH WAS TO GO AND LOCATE THE YOUNG BOYS FOR ME IN ORDER THAT WE MIGHT BE ABLE TO CAPTURE THEM. THIS HE AGREED TO DO, AND LEFT TOWN AT 10 A. M., FOR THAT PURPOSE, AGREEING TO MEET US TO-MORROW NIGHT AT JIM CANTLIN'S, IF THE YOUNG BOYS WERE AT HOME; OTHERWISE HE WOULD RETURN . AND MEET US ON THE ROAD, AND INFORM US OF THE TRUE SITUATION OF THINGS. THIS CONCLUDED OUR EFFORTS FOR THE DAY AND WE RETIRED ABOUT 10 P.M.,

LEAVING ORDERS TO BE CALLED AT 3 A.M. "

WEDNESDAY, SEPT. 26.

J. M. F. REPORTS, FROM RAWLINS: " WAS CALLED AT 3 A.M. AND AFTER HAVING A LITTLE BREAKFAST THOMELSON AND I STARTED ON FOOT AND WALKED AS FAR NORTH ON TOWN AS THE PAINT MINES WHERE SHERIFF MILLER OVERTOOK US WITH A TWO HORSE SPRING WAGON; WE GOT IN AND WENT TO SAND CREEK PASS, AND FROM THERE TO JIM CANTLIN'S RANCHE, ARRIVING THERE ABOUT 10 P.M., AND NOT MEET-ING DURBIN WE THOUGHT THE YOUNGS WERE AT HOME, AND EVERYTHING ALL O.K., BUT TO MY SUPPRISE WHEN WE ARRIVED AT JIM CANTLIN'S, DURBIN HAD BEEN THERE AND GONE, AND HAD LEFT NO WORD. AND THAT IS NOT THE WORST OF IT; WE HAD TOLD CANTLIN ALL ABOUT WHAT WAS TO TAKE PLACE, AND THE WHOLE PRO-CEEDINGS AND HE GAVE HIS PPINION THAT WE WOULD ALL BE KILLED, AND SAID EVERYTHING TO DISCOURAGE US. CANTLIN INFORMED ME UPON INQUIRY THAT DUR-BIN HAD LEFT FOR HIS RANCHE AND HAD LEFT NO WORD; ALSO THAT CLABE YOUNG HAD GONE TO RAWLINS THE NIGHT BEFORE, AND WAS AFRAID THAT HE HAD GOT WIND. OF WHAT WAS UP, AND HAD FLED. YOU CAN IMAGINE MY SITUATION AND FEELINGS; THERE WE WERE ON THE GROUNDS, CLASE GONE, DURBIN GONE, AND THE LATTER TELL-ING WHO WAS COMING AND WHAT WAS UP; BUT BEING IN THAT POSITION I DID THE BEST I COULD, AND AT ONCE GOT JIM CANTLIN TO FURNISH ME WITH A MOUNTED MESSENGER AND I SENT HIM AT ONCE TO DURBIN'S RANCHE FOR DURBIN; WE ALL THEN WENT TO THE HOUSE AND LAID DOWN FOR A FEW HOURS REST, WITH ONE STAND-ING GUARD TO CALL US AT THE PROPER IN THE MORNING. 11

THURSDAY, SEPT. 27.

J.M. F. REPORTS, SAND CREEK PASS, W. T.: "WAS CALLED ABOUT 3 A.M. AND FOUND THAT CLABE YOUNG, MRS. CASTRO AND THE BOYS HAD COME FROM RAWLINS ABOUT 2 A.M. AND WERE ALL AT HOME; WE THEN ORGANIZED AND AMBUSHED UNTIL THE BREAK OF DAY AND THE CAPTURE WAS PERFECTED WITHOUT MUCH TROUBLE, AND AS WE RETURNED WITH YOUNG TO CANTLIN'S HOUSE, WHERE WE BOUND HIM SECURELY IN 180NS, I FOUND THAT DURBIN'S FOREMAN, A MR. ORDWAY, HAD COME. HE INFORMED ME THAT HE REPRESENTED JOHN DURBIN, WHO WAS SIGK AND COULD NOT COME.

HE WOULD BE ABLE TO DO BY ME AS HE HAD PROMISED, AND THAT HE WAS SORRY, ETC. I TOLD ORDWAY TO TELL JOHN DURBIN THAT HE WAS A LIAR AND A COWARD. I HAVE HAD HINTS DURING THE LAST TWO DAYS OF THE STRONG INTIMACY OF DUR-BIN WITH TOM SUN, AND BILL AND CLABE YOUNG; AND I MAY HAVE SOMETHING FUR-THER TO SAY UPON THIS POINT BEFORE I GET THROUGH. AFTER TALKING WITH ORD-WAY FOR A WHILE HE SAID TO ME THAT HE THOUGHT HE COULD TOLE BILL YOUNG INTO RAWLINS. I TOLD HIM THEN TO DO SO AT ONCE, WHICH HE PROMISED HE WOULD AND STARTED IN THAT DIRECTION. I THEN HAD OUR HORSES HITCHED UP AND MIL-LER AND I STARTED FOR RAWLINS, WITH YOUNG, IN ONE MAGON, AND VAN, A DEPUTY AND THE CASTRO BOYS IN ANOTHER WAGON; BEFORE I LEFT CANTLIN'S RANCHE, HOW-EVER, I ORDERED CANTLIN TO TAKE HIS BEST HORSE AND SEND AT ONCE TO RAW-LINS, AND ORDER A SPECIAL TRAIN TO CONVEY CLABE OUT OF THE COUNTRY, FOR I WAS SATISFIED THAT THEY WOULD TRY AND RESCUE HIM FROM US. I ALSO ORDER-ED CANTLIN TO BE ON THE LOOKOUT FOR BILL YOUNG, AND ARREST HIM ON SIGHT. WE THEN COMMENCED OUR JOURNEY TOWARD RAWLINS, ARRIVING THERE ABOUT DUSK. THE SPECIAL WAS THERE AWAITING MY ORDERS, AND AS SOON AS I HAD MY SUPPER, SETTLED MY BILLS, ETC., I STARTED WITH THE PRISONER, BOSWELL AND THOMELSON, THE TWO LATTER AS ASSISTANTS. !!

FRIDAY, SEPT. 28.

J.M. F. REPORTS, FROM CHEYENNE, W.T.: "I ARRIVED KIN THIS CITY AT 5

A.M. WITH SPECIAL TRAIN, PRISONER AND ASSISTANTS AND TOOK YOUNG AT ONCE
TO THE COUNTY JAIL; GOT BREAKFAST AND REPORTED AT ONCE TO MESSRS, SWAN

AND CAREY, TELLING THEM HOW IT WAS THAT BILL YOUNG WAS NOT CAPTURED; AND
THAT IF JOHN DURBIN HAD NOT PROVED A TRAITOR AND I HAD ANOTHER CREW OF
THREE MEN I COULD HAVE GOT BILL JUST AS EASILY AS CLABE. THEY ORDRED ME
TO HUNT UP BOSWELL, AND BRING TO MR. S--- OFFICE, WHICH I DID, AND JUDGE
CAREY, SEARIGHT JACKSON AND MR. SWAN THOUGHT IT WAS BEST TO SEND BOSWELL
BACK AT ONCE, AND TRY TO CAPTURE BILL, AND BOSWELL BEING SO INSTRUCTED
LEFT ON THE MORNING TRAIN FOR RAWLINS. I HAVING BEEN OUT MOST OF TWO
NIGHTS FELT MOST WORN OUT, SO WENT TO BED AND RESTED MOST OF THE DAY.!!

SATURDAY, SEPT. 29.

J. M. F. REPORTS, FROM CHEYENNE, W. T. : "THIS MORNING, MESSRS. CAREY, SWAN AND SEARIGHT, THOUGHT IT BEST THAT I WAIT A DAY OR TWO WITH CLABE BEFORE STARTING FOR TEXAS, AND SEE IF BOSWELL GOT BILL, AND THEN TAKE BOTH ALONG AT ONCE, IF SO. THEY DECIDED IT WAS BEST FOR ME TO TAKE CLABE TO DENVER, WHERE THERE WOULD BE NO DOUBT ABOUT HIS SAFETY AND THAT HE WOULD THEN BE WHERE HIS FRIENDS COULD NOT GET AT HIM. ACCORDINGLY I DID SO, AND LEFT ON THE II A.M. TRAIN WITH YOUNG FOR DENVER. FOR THE BENEFIT OF THE COMMITTEE I WANT TO EXPLAIN WHAT TOOK PLACE IN THE CAR I WAS IN JUST ABOUT THE TIME THE TRAIN WAS ABOUT TO MOVE. A MAN CAME INTO THE CAR WHO WAS AN ENTIRE STRANGER TO ME, AND AS HE CAME TO THE SEAT OCCUPTED BY YOUNG AND MYSELF. HE REMARKED: 'HALLOO, CLABE, 'AND COMMENCED A CONVER-SATION WITH THE PRISONER. I SPOKE UP TO THE STRANGER AND SAID TO HIM, IF HE HAD ANY BUSINESS WITH THE PRISONER HE WOULD PLEASE DO IT THROUGH ME. HIS REPLY WAS TO ME THAT HE KNEW YOUNG AND COMMENCED CONVERSATION THE SECOND TIME. I AROSE AND BEGAN TO START THE STRANGER TOWARD THE DOOR, AND AS HE PASSED OFF THE PLATFORM HE CALLED FOR SHERIFF SHARPLESS AND HE AND SHARPLESS STARTED OFF TOGETHER. I INQUIRED WHO HE WAS AND JUST THEN VAN THOMELSON CAME UP TO ME AND SAID THAT IS THE EDITOR OF THE CHEYENNE LEA-DER. THIS IS THE FIRST I KNEW OF HIS BEING A NEWSPAPER MAN. THE TRAIN PULLED OUT FOR DENVER, AND ABOUT 4 P.M. I LANDED YOUNG AT THE COUNTY JAIL IN DENVER, AND WENT TO MY HOTEL FOR THE NIGHT. I WANT TO FURTHER REPORT THAT JUST PREVIOUS TO LEAVING CHEYENNE JOHN DURBIN IN COMPANY WITH MRS. CASTRO CAME TO THE COUNTY JAIL TO SEE YOUNG. I ALLOWED HER TO TRANSACT SOME FINANCIAL BUSINESS WITH HIM, AND THAT WAS ALL. DURBIN ASSURED YOUNG THAT HE WAS HIS FRIEND; HE HAD ALWAYS LIKED HIM AND HAD ALWAYS BEEN A FAITHFUL EMPLOYE IN THIS COUNTRY, AND WAS LEAVING LOTS OF FRIENDS BEHIND HIM, AND IF THERE WAS ANYTHING HE COULD DO FOR HIM TO JUST CALL UPON! HIM ANY TIME, AND TO FINISH UP HE INVITED MRS. CASTRO TO GO TO HIS HOUSE, AND BE HIS GUEST DURING HER STAY IN CHEYENNE. IF DURBIN HAD BEEN HALF SO ATTENTIVE TO ME AND THE INTERESTS OF THE STOCK ASSOCIATION, I KNOW HE

WOULD NEVER HAVE SO 'SICK.' AND BILL WOULD HAVE BEEN CAPTURED. THERE

WAS NOTHING BUT WHAT HE WOULD GLADLY DO FOR MRS. CASTRO AND HER MUCH INTRY

JURED LOVER, YOUNG. AND THE SIM OF WHAT HE DID DO WAS TO DEFEAT MY OB
JECT AND THE INTERESTS OF THE STOCK ASSOCIATION. IF HE LIED TO MRS. C-AND YOUNG AS HE DID TO ME MERCY AND HELP WILL BE ALONG TIME COMING. THINK

OF A MAN WHO GAVE HIS WORD AND HONOR HE WOULD LOCATE THE YOUNGS FOR ME,
AND THEN WHEN I GO ALL THE WAY TO CANTLIN'S AND FIND THAT HE HAS PROVEN

UNFAITHFUL AND THEN SEND FOR HIM, AND HE SENDS WORD BACK THAT HE IS SICK

AND SENDS ORDWAY IN HIS STEAD, WHO PROVED HIMSELF TO BE ANOTHER LIAR, WHEN

HE SAID THERE WAS NO DOUBT THAT HE COULD TOLE BILL TO ANY PLACE, AND FOR

US TO GO AND HE WOULD HAVE HIM IN TOWN, ETC. I WISH TO REPORT FULLY IN

REGARD TO THAT GENTLEMAN, FOR HAD HE DONE HIS DUTY I WOULD HAVE HAD BILL

JUST AS EASILY AS CLABE, AND I MAKE THE DIRECT CHARGE AGAINST HIM, AND HAD

HE DONE HIS DUTY AND PROVED FAITHFUL AS I SUPPOSED HE WOULD BILL WOULD

HAVE SEEN LANDED IN TEXAS WHERE HIS BOTHER CLABE NOW 15.''

SUNDAY, SEPT. 30.

J. M. F. REPORTS, FROM DENVER: 1 AT 1 P. M. I TOOK TRAIN AND RETURNED TO CHEYENNE, AND UPON MY ARRIVAL MET MR. EVANS OF THE FIRM OF MESSAS, HAWES & EVANS, WHO SHOWED ME A COPY OF EACH OF THE SUNDAY MORNING CHEYENNE PAPERS AND DENOUNCED THEM IN SEVERE TERMS. THE ONLY EXPLANATION I HAVE TO MAKE IS FULLY DESCRIBED IN MY REPORT OF YESTERDAY, WHERE I SPOKE OF HAVING TROUBLE WITH A STRANGER WHO CAME INTO THE CAR TO TALK WITH YOUNG, AND TURNED OUT TO BE THE EDITOR OF THE LEADER. ARTICLES OF THAT KIND BON'T WORRY ME MUCH, NOR NEVER HAVE. I HAVE LEARNED LONG AGO THAT EVERY CRIMINAL HAS HIS FRIENDS AND EVERY TOWN ITS OFFICERS WHO ARE JEALOUS OF MEN IN MY BUSINESS; ALSO THAT NEWSPAPERS TAKE SIDES WITH THE CRIMINALS, AND UPON THIS POINT I WOULD ONLY ASK THAT YOU READ THE PAPERS OF YESTERDAY MORNING AND ALSO THIS MORNING AND YOU WILL PLAINLY SEE THE CAUSE OF SUCH AN ATTACT UPON ME. AS BOSWELL MIGHT BE DOWN FROM RAWLINS WITH BILL TOMORROW. THERE WAS

MUCH TALK ON THE STREETS ABOUT THE ARTICLES IN THE SUNDAY PAPERS, AND MANY

OF THE CATTLE MEN WANTED ME TO WRITE AN ANSWER, BEGIN A LIBEL SUIT, ETC.

BUT I SAILED, AND SAID, 'NO, IF I WERE TO STOP AND PAY ANY ATTENTION TO

TAKE CLABE TO CHICAGO, AND THERE GO TO WORK ON HIM TO OBTAIN A CONFESSION. THIS SEEMED TO MEET WITH THE APPROBATION OF ALL THE ABOVE NAMED

GENTLEMEN, AND WITH THAT VIEW I STARTED FOR CHICAGO."

J.M. F. REPORTS, FROM OMAHA, NEB.: "ARRIVED IN THIS CITY WITH PRIS-ONER AT 3 P.M., AND CONTINUED MY JOURNEY TO CHICAGO, VIA THE C. B. &. Q. R. R."

J. M. F. REPORTS, FROM SAME PLACE: "THE CAPTAIN AND I AT DIFFERENT

TIMES DURING THE DAY AND EVENING HAVE BEEN LABORING WITH YOUNG, BUT HE DE-CLARES THAT HE KNOWS NOTHING PERTAINING TO CATTLE STEALING, AND OTHER CRI-MES THAT WE GAVE HIM TO UNDERSTAND HE WAS CHARGED WITH. MR. JACKSON CAL-LED AND SEEMED TO BE MUCH PLEASED, AND SAID IT WOULD BE A GLORIOUS THING IF WE COULD GET HIM TO CONFESS.!!

SUNDAY, OCT. 7.

J. M. F. REPORTS, FROM SAME PLACE: "YOUNG HAS BEEN QUITE SICK ALL DAY;
HAD THE DOCTOR ONCE; HE CRIES LIKE A CHILD BY SPELLS; IS MUCH AFRAID!

THAT HE WILL BE HUNG UPON HIS ARRIVAL IN TEXAS."

MONDAY, OCT. 8.

J.M. F. REPORTS, FROM SAME PLACE: ''TO-DAY THE CAPTAIN AND I HAVE STILL BEEN UNABLE TO ELICIT ANYTHING THAT WOULD HAVE BEEN CONSIDERED IMPORTANT; YET HE SHOWS, SOME SIGNS OF WEAKENING, AND WE THINK IT BEST TO PLAY THE ATTORNEY RACKET WITH HIM TO-MORROW, AND SEE WHAT CAN BE ACOMPLISHED IN THIS WAY.''

WEDNESDAY, OCT. 9.

J. M. F. REPORTS, FROM CALRO, ILL.: "YOUNG VERY SICK AND RESTLESS; STILL ON OUR WAY TOWARD SANANTONIO."

THURSDAY, OCT. 10.

J.M. F. REPORTS, FROM NEWORLEANS, LA.: "ARRIVED IN THIS CITY ABOUT NOON; YOUNG QUITE SICK; HE ASKED FOR A DOCTOR, AND I SECURED THE SERVICES OF ONE; AND THE DOCTOR THOUGHT IT BEST TO TAKE ONE DAY'S REST, WHICH I DID."

FRIDAY, OCT. 11.

J. M. F. REPORTS, FROM NEWORLEANS: "LEFT THIS CITY THIS P.M. AS WE GET NEARER OUR DESTINATION YOUNG APPEARS TO GROW MORE RESTLESS."

SATURDAY, OCT. 12.

J.M.F. REPORTS, FROM SANANTONIO, TEX. : "ARRIVED IN THIS CITY AT 5:10 P.M., AND AFTER PUTTING YOUNG IN THE COUNTY JAIL WENT TO MY HOTEL FOR THE NIGHT."

SUNDAY, OCT. 12.

J. M. F. REPORTS, FROM SAME PLACE: " WENT TO THE JAIL THIS MORNING ABOUT O O'CLOCK, AND LEARNED THAT MRS. CASTRO WAS IN THE CITY, AND HAD GONE TO THE SHERIFF AND REPRESENTED HERSELF AS CLABE'S WIFE, AND THE SHERIFF BE-ING UNDER THAT IMPRESSION DIRECTED HIS_JAILOR BY WRITTEN ORDER TO ALLOW AN INTERVIEW BETWEEN THE TWO, AND IN THE PRESENCE OF THE JAILOR THEIR CON-VERSATION WAS ABOUT AS FOLLOWS. SHE INFORMED HIM THAT THIS WAS A MALICI-OUS PIECE OF BUSINESS; TOLD HIM TO KEEP UP HIS COURAGE; THAT JOHN DURBIN, C. E. JOHNSON, TOM SUN, BONEY EARNEST AND JOE RANKEN WERE ALL HIS FRIENDS, AND THAT THEY WOULD GET AT THE STRAIGHT OF THIS AND LET HIM KNOW ALL A-BOUT IT; SHE ALSO INFORMED HIM THAT TOM SUN AND C. E. JOHNSON WOULD FUR-NISH HIM !CLABE! WITH ALL THE MONEY HE WANTED. C. E. JOHNSON FURTHER SENT WORD BY MRS. CASTRO TO SEND A BILL OF SALE FOR ALL HIS HORSES, STOCK AND INTEREST IN ALL HIS PROPERTY AND HE WOULD PROTECT IT FOR HIM, AND BESIDES LOAN HIM ALL THE MONEY HE WANTED. I WOULD SAY HERE THAT CLABE DID SIGN POWER OF ATTORNEY IN JOHNSON'S FAVOR, WHICH WILL BE IN HIS HANDS AS SOON AS THE MAIL CAN CARRY IT. MRS. I WILL SAY THIS I KNOW TO BE RE-LIABLE, FOR AFTERWARDS I PUT MYSELF IN POSITION AND HEARD THE SAME CON-VERSATION OVER AGAIN UNKNOWN TO THEM; AND IN ADDITION HEARD THE MOST OF A LETTER READ FROM BILL, THAT WAS MAILED AT FERRIS, TO HIS BROTHER-IN-LAW IN TEXAS, BY THE NAME OF BOCK, WHEREIN HE ASKS THAT ALL BE DONE FOR CLABE THAT CAN, AND THAT HE THROUGH JOHNSON SEE THAT CLABE HAVE ALL THE MONEY HE WISHED; SO THERE IS NO DOUBT BUT WHAT HE IS THERE, AND FOR THE BENE-

REACH HIM IN SAFETY, AND THAT IS TO DO IT THROUGH THIS MAN JOHNSON, AND
BY A DECOY LETTER. WITH WHAT I KNOW AT PRESENT I FIRMLY BELIEVE A DECOY LETTER COULD BE SO FRAMED AND WORDED AS TO TOLE HIM!BILL! OUT OF THE
HILLS ON TO THE R.R. AT OGDEN, OR SOME PLACE ON THE OREGON SHORT LINE;
HOWEVER, THIS WILL BE A MATTER FOR FUTURE CONSIDERATION."

J. M. F. REPORTS, FROM SAME PLACE: "DURING THE DAY I HAD QUITE A LONG TALK WITH CLABE IN THE JAIL, AND WITH THE POINTS AS DESCRIBED IN MY RE-PORT OF YESTERDAY I WENT AT IT ONCE MORE, AND HE ADMITTED TO ME SOME VERY MATERIAL FACTS WHICH WERE AS FOLLOWS: IN REGARD TO THE CATTLE STEALING IN WYOMING HE SAID THAT HE KNEW THERE WAS SOME GOING ON, AND THAT D--D--OLD SERIGHT WOULD NOT HAVE A COW LEFT BY THE TIME SOME OF THE BOYS GOT THROUGH WITH HIM. 'WHY, JOHN COOPER TOLD ME, AND SO DID BONEY EARNEST.' I THEN INQUIRED, 'BONEY EARNEST KNEW THEN, AND SO, HE WAS IN THE SCHEME ?' HE REPLIED, 'YES, YOU BET; BONEY HAS BEEN IN FOR TWO YEARS, AND IS HUS-TLING CATTLE ABOUT WITH ANY OF THE BOYS.
