REPUBLICAN

I am a Republican and I take pride in my party and its record (state here what, if any, Republican position you hold and say the party has honored you with such appointment).

The Republican Party went on record unequivocally in 1916 in its National Convention for the establishment of woman suffrage. During the 65th Congress when the Democrats had a majority in both Houses, the National Republican Committee passed a strong resolution favoring the immediate submission of the Federal Suffrage Amendment. In (1918) the elections gave a majority of Republicans in both Houses of Congress, and in the 66th Congress the Republicans lived up to their promises and submitted the Federal Suffrage Amendment. The National Republican Committee again went on record, being the only official representative of the Republican Party in the interim of conventions, and urged immediate ratification. Later at another meeting of the committee, it again went on record, this time urging special sessions of legislatures in order that women might have the vote in the presidential election of 1920.

These resolutions of promise made Republican women throughout the land proud of their party. The great American and the greatest Republican. Abraham Lincoln, described this country as a Government of the people, by the people and for the people, and Republican women began to feel that at last the Republican Party was going to make good the definition of their great leader.

o my Through our o Of the forty-eight states in the Union, thirty have Republican Legislatures. Since the Republican Party is now in control of the Legislatures in much more than a majority of the states, and is in control of both Houses of Congress, ratification became chiefly a Republican responsibility. Thus far the Republican states have responded to this obligation, and twenty-seven of the thirty legislatures have ratified the Federal Suffrage Amendment. The three remaining are Vermont. Connecticut and Delaware. We are informed that Delaware, despite its delay, will ratify the Amendment. We are also informed that the Legislatures of Vermont and Connecticut stand ready to ratify whenever their Governors will call them into

special session.

When the suffragists of the Nation ask the Governor of Connecticut to call a special session in order that the legislators of this state, already pledged to ratify, may express their will, they are asking nothing new and nothing strange.

Already twenty-two Republican Legislatures have been called in special sessions because the Governors of those states recognized that making an end of the long struggle for the enfranchisement of women in this country is an emergency which demanded immediate action.

organize on behalf of the Republican Party in the coming election. A National Committee of Republican women to oversee this organization has been appointed, and another National Committee of women has been appointed for the purpose of raising funds from Republican women to defray the expenses of the coming campaign. In order that these women may serve their party loyally, cheerfully, energetically and with hearts filled with real devotion, it is necessary to give them a clean record of this question. I want to see every Republican Legislature ratify the Federal Suffrage Amendment in order that Republicans may say that a Republican Congress submitted the question, and every Republican Legislature ratified.

I do not expect that a clean record is going to bring women, born and bred in the Democratic Party, into the Republican Party. We know the Republicans do not have Legislatures in thirty-six states, and that the Amendment could not have been submitted by Congress, her could the Amendment have been ratified had it not been for Democratic help. But a clean record will have the effect of stimulating Republican women to a heartier support of their party and to a greater willingness to make sacrifices for it.

This is the situation. Thirty-five states have ratified the Amendment.

We need one more to make it operative and until that one Legislature has been called and has been ratified then the campaign for woman suffrage must go on. Women must

continue to give their money, their time, their energies to that campaign instead of to the support of the parties of their choice.

Meanwhile, what is to be the effect upon the women who want to support the Republican Paety, who want to work for it, who want to sacrifice for it, if it is to be said that the task is uncompleted and that women in all states cannot vote because Republican Governors have refused to call sessions in order to provide oppore tunity for ratification.

It must not be forgotten that the women of this country have the vote for President in twenty-nine states, but women very naturally feel that this is not enough suffrage to warrant the devotion of much time or effort. It is humiliating to women to vote in one ballot box to which their privilege is limited, while every sort and kind of man is permitted to vote in another box where all candidates are under consideration. They do not enjoy the discrimination.

Let me repeat, we cannot lay the responsibility of this discrimination upon the Democrats because the Republicans are in majority and in control of a majority of states and of Congress. Therefore I appeal to you Republicans of Connecticut to make in turn your appeal to your Governor and beg him to put Connecticut right with a majority of the Republican Party, and that is, call a special session, ratify and make an end to the long, long struggle for the enfranchisement of women.
